The objective is to obtain the judgment of conviction to the Brazilian State for the violation of the Human Rights inflicted along the Rio Doce basin. The initiative was a joint between Homa, FIAN Brasil, Grupo de Estudos e Pesquisas Socioambientais (GEPSA), Justiça Global, Movimento dos Atingidos e Atingidas por Barragens (MAB), e Núcleo de Direitos Humanos da Universidade Federal de Ouro Preto (UFOP).
